## New Mayor and Council Appointments

On January 3, Judge Thomas Caulfield swore in Mal Hellett as Mayor of Edgewood. Mr. Hellett has served on Council for seven years. His responsibilities have included Vice President of Council and Chair of Public Safety and Personnel Committee. His appointment will expire January 2, 2012.

George Fuller was sworn in as Council member to replace Mr. Hallett. Mr. Fuller was a member of Council from June 2009 until January 2010 and has represented the Wilkinsburg-Penn Joint Water Authority for the borough for the past seven years. His term will also expire on January 2, 2012.

Please note that there will be three 4- year Council terms and one 2-year term, as well as the remaining twoyear term for mayor, open for election in November. ## Police Report

#### Traffic Stops


Edgewood Police officers are well known for conducting many traffic stops on a daily basis. We would like to offer some advice, as well as some knowledge, in this matter. During a traffic stop, an officer has discretion to issue a verbal warning, written warning, citation, or possibly make an arrest. The seriousness of the violation and your conduct are factors that an officer may consider when determining which is proper for you to receive.

When an officer has his/her emergency lights activated, you are required to move safely to the extreme

right side of the roadway as quickly as possible. An officer will then have room to safely navigate the roadway, which provides for everyone's safety. You may be blinded by a spotlight immediately if it is dark outside. This is done for officer safety, so that we can see clearly into the vehicle. Please do not reach around the vehicle gathering your information. Please understand that we do not know who we just pulled over or what you may be reaching for. If it is night time, please turn on your interior lights. It is important to keep your hands where the officer can see them and is of utmost importance that you remain inside your vehicle.

Each officer's technique may differ as they approach your vehicle. Typically, the officer will ask for your driver's license, insurance card and registration and you will be advised why you were stopped.

Many times officers will hear, "Why did you stop me?" "The light was

yellow," "I did stop," or "I wasn't speeding," before we even get a chance to explain. This portion of the stop may decide whether you will receive a citation. If you remain calm and give the officer an opportunity to explain why you were stopped, you will be given an opportunity to offer a response. If you respond with honesty, the officer will listen. Officers are people too, and may have been stopped while they were off duty or before they even became an officer. We can relate to being late for work or being distracted by children; admitting guilt will not hurt you anymore at this point, it just shows us that you are willing to take responsibility for your actions.

If you do receive a citation for the violation, this is not the time to argue. If you truly feel that you are right, you may request a court hearing. At the hearing, you will be able to state why you feel you are right in front of an impartial judge. The officer will testify as well. The judge will then find you guilty or not guilty. A judge also has the power to show leniency and reduce the fine or points in some situations. If you still do not agree, you can appeal the local magistrate's decision and another hearing will be scheduled in front of a different judge.

One misconception which some citizens may have is with regard to quotas. It is illegal for anyone to tell officers how many tickets to write. If an officer writes ten citations a day or ten in a year, there can be no repercussions.

Another myth is that officers only write citations to make money for the Borough. The typical fine in Penn-

sylvania for a moving violation is \$25 (without costs, etc. added in). The Borough will receive less than ten dollars of this, which is in no way a money maker.

One popular and frequently asked question is, "Don't you have anything better to do?" The initial traffic stop may lead into other areas and are actually the basis for citizen contacts which may lead to a criminal arrest. For example, the person stopped may have illegal contraband in the car, such as narcotics or a firearm, which they may not be entitled to carry. Both Ted Bundy and Timothy McVeigh were both caught after minor traffic violations.

### EDGEWOOD POLICE ACTIVITY REPORT FEBRUARY 2011

The Edgewood Police Department responded to and handled 1,145 calls for service in December 2011. There were 484 incidents reported, 132 complaints received and 9 accidents investigated, 2 of which resulted in personal injury, and 7 resulted in property damage.

Part I Crimes are the more serious crimes of Homicide, Rape, Robbery, Aggravated Assault, Burglary, Larceny, Motor Vehicle Theft and Arson. Of the 12 Part I Crimes committed in the Borough, there were 2 for Robbery, 0 for Motor Vehicle Theft, 2 for Burglary, 5 for Shoplifting, 0 for Aggravated Assault and 0 Other Crimes.

There were 8 adult and 4 juvenile arrests made for Felony and Misdemeanor violations.

Edgewood officers wrote a total of 41 Traffic Citations, 103 Parking Citations and 1 arrest for Driving Under the Influence was made. There were 3 Vandalism/Criminal Mischief Complaints and 1 Narcotics Offense.

Officers also responded to 14 False Alarm Calls, took 259 reports, responded to 0 Public Nuisance Complaints, wrote 6 Non-Traffic Citations and responded to 11 calls for Medical Assistance.







### Parking Changes Ahead

Council has made changes to the borough's overnight on-street parking ordinance. The current call-in system for overnight guests will be changed to a permit-only system. A hanging tag will be issued to residents for their overnight visitors for a fee of \$15 per year for each pass. This pass may be transferred from one visitor's car to another and is valid for the entire year. The Borough has handled over 5,000 calls so far this year regarding overnight visitor parking and can no longer manage the administrative demands of this policy. The borough makes every effort to match fees with the administrative costs of the service and/or enforcement costs. Due to the savings from ending the call-in system, the borough has reduced the price of a resident's on-street parking pass to \$15/ per year. As a reminder, each driver with a vehicle registered in the borough is able to purchase a residential parking





pass. Visitor passes may not be used on any vehicle that is registered within the borough. The fee for borough lots and recreational and commercial vehicles remains unchanged. Permits for 2011 will be available at the borough building beginning December 6, 2011.

### Mel Douglass Scholarships to Be Awarded Again

Are you a high school senior with an outstanding record of community service? Then you have the opportunity to earn a scholarship from the Mel Douglass Fund. These scholarships honor the memory of Mel Douglass, who provided exceptional leadership and volunteer service to numerous Edgewood organizations. Last year, four high school seniors from Edgewood earned scholarships for their community service achievements. The scholarships are available again this year to high school seniors living in Edgewood and planning to pursue degrees.

The 2011 Mel Douglass Scholarships will be presented at the annual Edgewood Foundation brunch in May for the borough's graduating seniors. The primary scholarship is \$4000, paid in \$1000 installments for each year of undergraduate school. Honorable mention scholarships of \$500 also are available.

Mel Douglass grew up in Edgewood, graduated from Edgewood High School in 1970 and from the University of Pittsburgh. Mel actively volunteered in multiple community service roles in Edgewood ranging from volunteer fireman to Little League coach to church deacon before he passed in an airplane accident in 1994. These facts only hint at Mel's true legacy, which is the wide circle of lives he enriched with his larger-thanlife personality, unquenchable spirit and commitment to serving others.

A group of his friends started these scholarships in 2008 to sustain Mel's legacy and his love for Edgewood. Andrea Thieman won the first Mel Douglass Scholarship, followed by Anne Hazlett in 2009 and Adrienne Lewis last year. Ten other Edgewood students have earned honorable mention scholarships.


### Lending an Artistic Hand
