2013 Budget Highlights


The 2013 General Fund Budget was approved by a unanimous vote of Council on December 17, 2012. The 2013 Budget estimates revenues and expenses at \$2,779,341. The budget balances with approximately \$44,000 carried over from a surplus in 2012 and keeps the Borough's property millage rate revenue neutral (more on this at the end of the article).

Notes on Revenue:


- Property taxes are expected to bring in the same revenue as 2012, although a small increase is possible due to increased legal efforts by the Borough to collect overdue taxes.
- Earned income taxes (0.5% payroll tax from all residents) have increased over 11% (up approximately \$60,000) from the 2012 Budget. This is possibly due to the removal of a 3-month lag time in collection; however, Act 32 was also enacted in 2012 and it is possible that the tax is being levied on residents who were previously being 'missed.'
- Allegheny County Sales tax (RAD) is expected to bring in \$73,000 to the Borough in 2013 (an increase of \$5,000 from the 2012 Budget).

Notes on Expenses:

- Salaries of non-union Borough employees were raised 3%.
- Medical Insurance rates for all Borough employees will increase approximately 12%.



- Newsletter printing and postage costs are estimated to drop about \$10,000 (due to decrease to 6 issues per year).
- Newsletter editing has been brought in-house (savings of about \$10,000).
- Commercial Insurance has increased \$13,000 (to \$65,000).
- Unemployment compensation is expected to decrease \$12,000.
- Street Maintenance (road paving) is allocated \$100,000 (increase of \$28,000 from 2012 Budget).
- Facility maintenance has increased \$40,000 to \$100,000 due to the need for new windows and other maintenance on the Borough building.
- Recreation expenses will decrease about \$6000 this year due to continued volunteer support and other cost-saving efforts.



Council Notes

Local Government, it all starts.....with you.

This year there will be four seats open for Borough Council. Good governance requires a multifaceted approach. While each member of Council brings their own experiences and areas of expertise, each member shares in a commitment to continue to move Edgewood forward and to remain a solvent community. Council and the mayor work to keep our streets safe, our real estate values stable, our community-based traditions alive and to protect our access to employers, recreation and culture.

Participating in the Turtle Creek Council of Governments, CONNECT and the Local Government Academy offerings have provided new insights and options for more effective bidding and planning. This has laid the ground work for a strong network of inter-municipal communication and cooperation and allowed us to be proactive in stopping PennDOT's plan to close and meter the Parkway ramps of Forest Hills and Edgewood and Swisvale. (More to come on that in a later issue.)

The EPA municipal and ALCOSAN Consent Decrees will be the largest most expensive Public Works effort this region has ever encountered. We continue to participate in the Basin groups of 3Rivers Wet Weather, whose goal is to correct, improve and maintain the infrastructure of our sewers and support our county and state representatives: Congressman Mike Doyle, State Senator Jay Costa, State Representative Paul Costa, Chief County Executive Rich Fitzgerald, and County Council Commissioner Charles Martoni. These representatives have endeavored to bring state and federal recognition to the impact of the

Consent Decrees, our regional efforts and our desire to incorporate green infrastructure into our plans. We are also working to obtain funding to our region which will benefit Edgewood and neighboring communities.

In order to improve our school district, we remain active in the Inter-Council and work with Marilyn Messina, our district representative and the School Board Vice President. Our goal is to promote Woodland Hills School District's success and to keep Edgewood Primary School as an integral part of the school district and an important community resource.

If you are interested in becoming involved in local government, the Local Government Academy is offering Contemplating Governing: A Course for Potential Candidates for Local Office, Wednesdays, January 30, February 6 and February 20, 2013 from 6 PM - 9 PM at the Green Tree Municipal Building.

Contemplating Governing is a three-part program which includes the following:

- Understanding the powers and duties of various boards and commissions
- Understanding local government taxation and services
- Local government's important role in community sustainability
- How to overcome obstacles to run and to meet legal requirements
- Ways to measure a board's effectiveness.

Edgewood Recycles

Pennsylvania Covered Device Recycling Act (HB 708)

The Department of Environmental Protection is advising consumers and businesses of new rules for recycling electronic devices that will take effect on January 24, 2013. Enacted in 2010, the Pennsylvania Covered Device Recycling Act requires that consumers not dispose of covered devices, such as computers, laptops, monitors and televisions, with their trash.

Waste Management, the garbage company for most Edgewood residents, will no longer be accepting computer equipment ("e-waste") and televisions in the trash as of January 1, 2013. This equipment is not allowed in PA landfills, and it is your responsibility to see that these items are appropriately recycled.




Police Report

Privacy and Identity Theft Protection

Today, people are often required to share personal information when they engage in business or personal transactions. Identity thieves gather an individual's personal information without their knowledge and then use the information to commit fraud or theft.

Victims are often unaware that their identity has been stolen until it is too late. It can take months or years and thousands of dollars to rectify the problems created by identity theft.




How does an identity thief gather information?

- Stealing wallets and purses containing ID, debit and credit cards
- Stealing mail – including bank and credit card statements
- Posing as a telephone solicitor
- Observing ATM transactions
- Fraudulent internet sites and scams
- Fraudulently obtaining credit reports
- Hacking into computer networks at work or at your home
- Sharing personal information through online social networks, such as MySpace and Facebook
- Rummaging through trash and other discarded paperwork


How identity theft affects you:

- Your personal information is used to open new credit card or cell phone accounts or loans; account balances are left unpaid.
- Your billing address is changed on your credit cards, bank statements, or cell phone accounts to divert your mail to a different location, hiding discrepancies in your billing statements.
- New bank accounts are opened in your name against which bad checks are written.
- All or some of your bank account balance is withdrawn using counterfeit checks, debit cards, or electronic transfers that appear to be authorized by you.
- A bankruptcy is filed in your name to avoid eviction or other collection practices.
- An ID or driver's license is created using your information and is then used by an impostor, claiming to be you.

How do I avoid becoming a victim?

- Obtain a copy of your current credit report at least once a year and review for discrepancies.
- Never give out personal information,

- such as your social security number or date of birth, over the Internet or phone.
- Never carry important personal documents such as your social security card, birth certificate or passport, unless absolutely necessary.
- Cancel and destroy all unused credit cards and keep track of your current credit cards by reviewing statements on a monthly basis.
- Memorize pin numbers and other important numbers or passwords; never write them down.
- Shred all papers containing personal information before discarding, including bills, bank statements, receipts and credit card offers that are pre-printed with your name.
- Password-protect and/or encrypt PDAs, computers, cell phones, flash drives and hardware of any kind that contain sensitive personal information.
- By using common sense, you can avoid becoming the victim of a scam; remember if it sounds too good to be true, it probably is!

- Contact your credit card companies and banking institutions immediately.
- Contact the police department in the location where you believe the theft took place.
- Report suspicious activity regarding your mail to your local post office.
- File a complaint with the Federal Trade Commission and complete the Identity Theft Complaint

Under Federal law, every person has the right to receive a free credit report once every 12 months from each of the three nationwide consumer reporting companies:

- Equifax
- Experian
- Trans Union

- Don't walk or jog alone.
- Walk in well-lighted and populated areas.
- Stay alert and attuned to things around you, especially suspicious persons or activities.
- Lock your car and residence to prevent theft.
- Keep your valuables, purse or wallet out of plain view from the windows, doorways, and cars.
- Have your keys ready to enter your residence or car as quickly as possible.
- Be confident. Walk and carry yourself with confidence.
- Get acquainted with your neighbors. Know who belongs and who doesn't.
- If you're going somewhere alone or with a new friend, let someone know where you are going.

Mel Douglass grew up in Edgewood, graduated from Edgewood High School in 1970 and the University of Pittsburgh. He married his high school sweetheart, raised two wonderful children and launched a successful business career. Mel actively volunteered in multiple community service roles in Edgewood, ranging from volunteer fireman to Little League coach to church deacon, before he passed in an airplane accident in 1994. 

What does the 2013 Real Estate Reassessment Mean to You?

Due to the reassessment of all real estate in Allegheny County, Edgewood Borough's millage rate for 2013 is set at 5.65 mills. This is a decrease of 2.511 mills from the previous year. This decrease makes the new millage rate "revenue neutral." This means that the Borough expects to collect the same property tax revenue as in 2012. More on this subject in the next issue.
