Motion to authorize payment of bills- Ms. Gleba

I move to authorize the payment of bills, for goods and services received by the Borough, having been reviewed and approved by the General Government Committee, from the General Fund in the amount of \$184,829.08 and from the Sewer Fund in the amount of \$804.30, for a total of \$185,633.38.

Public Works Employees -- Motion to Hire -- Mr. Wilson

1. I move to hire Louis Sloan as a full time Public Works Employee at a starting wage of \$12.00 per hour plus benefits as outlined in the Borough Personnel Manual. This is contingent on Louis passing a physical, drug screening and background check.

2. I move to hire Dustin Ginsburg as a part time employee for the Public Works Department at a starting wage of \$10.00 per hour with no other benefits. This is contingent on Dustin passing a physical, drug screening and background check.
