BUSINESS MEETING

VOLUNTEER FIRE DEPARTMENT

Mr. Laird reported that the Volunteer Fire Department met December 22, 2006 and the following officers were chosen: Mr. Laird – President, Mr. Rickard – Vice President, Mr. Halle – Secretary, Mr. Krumholz – Treasurer.

Mr. Laird mentioned the fire which had occurred on Walnut Street. He also talked about the arrival of the new rescue truck and invited all Council members to stop and see the truck. The manufacturer will provide all brackets for the equipment and it is estimated that the equipment will be put into service by the first of February. Mr. Laird said that there will be a grand opening, to which the Borough residents will be invited to come and see the new truck.

DISCUSSION: Mayor Davin asked if there will be a Christmas tree burn as in previous years and was answered in the negative. Mr. Laird explained that this process tears the field up. The Mayor then spoke about a tree burn in Forest Hills and asked whether Council wanted to call that borough to see if they want Edgewood's trees.

RECREATION COMMISSION REPORT

Mr. Ferguson reported that Ms. Barrante is back to work. He stated that basketball begins this coming Saturday and that registrations are still being taken. Practices are being held at both the Edgewood Primary School and the Western PA School for the Deaf.

WATER AUTHORITY REPORT

Mr. Fuller reported that the Authority did not meet in December.

DISCUSSION: Ms. Schaefer thanked Mr. Fuller for his willingness to serve and his diligence to the Borough.

Mr. McNally reminded everyone the he has not served on the Planning Commission for quite some time. He went on to say that Mr. Szefi had not left any information for him to report this evening.

Mr. Hellett stated that he did not attend the meeting due to conflicts.

DISCUSSION: Ms. Schaefer indicated that she will be the alternate for attendance at the COG meetings.

SOLICITOR'S REPORT

Mr. Barry reported that he has reviewed the Tax Anticipation Note and has given an opinion letter on this. He indicated that he had a personnel matter for the Executive Session, but that there would be no Council action required.

BOROUGH MANAGER REPORT

Mr. Ferguson said that he is in the process of meeting with staff and department heads regarding financial and budget issues for this and next year's budget. Guidelines on spending will also be set, according to Mr. Ferguson.

The bid for the garbage contract will be sent out in the coming year. Mr. Ferguson stated that he was pleased with the recent weather for a number of reasons, including the fact that the supply of rock salt has been maintained at a high level and the fact that there has been no overtime due to icy or snow conditions. According to Mr. Ferguson, one Public Works employee is off and has been following up with treatment for an injury sustained during the one snow day that did occur.

Mayor Davin suggested contacting Forest Hills and surrounding communities to make a conglomeration of communities to bid out the garbage contract. It was the Mayor's goal to try to maintain the millage at its current rate.

Mr. Ferguson indicated that his plan has been to find out the per unit examples per community to see if there is a differentiation of marginal costs. He stated that Edgewood Borough's per unit cost is \$113, with an average per unit cost being \$160 - \$170. Mr. Ferguson will get prices from other boroughs.

Mayor Davin reported that Wilksburg accepted a contract with the City of Pittsburgh, further stating that they may also be willing to go into a conglomeration.

Mr. Ferguson expressed that he had other concerns about having Edgewood Borough's garbage collection merged with the City of Pittsburgh, further stating that the question in the end is how communities are billed and the responsibilities for payment.

NEW BUSINESS

A General Government Committee meeting was scheduled for January 8, 2007 at 7:30 PM and a Pension Committee meeting was scheduled for January 22, 2007 at 7:30 PM.

A list of people to receive the Port Authority communication was reviewed by Mr. McNally. He asked that Mr. Ferguson ready the document for signature.

Mayor Davin informed Council of the Mayors' Meeting on February 1, 2007 at 6:00 or 6:30 PM at the Braddock Hills Holiday Inn. She stated that County Executive Onorato would be the keynote speaker.

Ms. Schaefer referred to the upcoming Council of Government dinner in February and offered that Junior Councilperson Bush might attend. Ms. Schaefer also asked Mayor Davin to check to see if it might be appropriate for Ms. Bush to attend the Mayors' Meeting.
