## BOROUGH OF EDGEWOOD MINUTES OF THE MEETING OF COUNCIL HELD MONDAY, MAY 18, 2009

Vice President McDonald called the Meeting of the Council of the Borough of Edgewood to order on Monday, May 18, 2009 at 7:34 PM in the Municipal Building.

Borough Manager Warren Cecconi called the roll and the following responded: Ms. McDonald, Mr. Shultz, Mr. Reynolds, Mr. Szefi, Mr. Cook.

Ms. Schaefer and Mr. Hellett were absent.

Mayor Davin and Borough Solicitor Representative Worner were also present. The Junior Councilperson was absent.

The Pledge of Allegiance was recited.

## **ITEMS FROM THE FLOOR**

Ms. Schano of the Edgewood Foundation gave her report, stating that twenty one (21) volunteers helped with Clean Up Day. For next year, according to Ms. Schano, efforts will be made to recruit more volunteers.

The Senior Brunch was hosted by the Edgewood Foundation on Mothers' Day and sixteen (16) students participated with a total of seventy six (76) people in attendance. Ms. Hazlett of Washington Street received a \$4,000 scholarship.

Ms. Schlesinger of LaCrosse Street spoke of the street's need for major repair. She stated that she spoke to the borough managers from both Swissvale and Edgewood, as this would be a shared responsibility. Ms. Schlesinger said that a petition has been initiated. From a previous meeting it was determined that there were many issues with LaCrosse Street, including damaged vehicles and sunken cobblestones and the possibility of speeding when repaired.

Before proceeding, Ms. Schlesinger wanted to talk with the Borough and its engineers and try to find a way to save the cobblestones.

Mr. Cecconi stated that he is talking with Ms. Ford at Swissvale and is currently awaiting a response.

Mayor Davin indicated that this has been brought up several times before and the issue will be reviewed. The Mayor stated that the cobblestone replacement is nearly cost prohibitive. She stated that she has spoken with the Swissvale Mayor and County Executive Martoni regarding this issue.

Ms. McDonald agreed that this has been a discussion for years and assured Ms. Schlesinger that Mr. Cecconi will keep her in the informational loop.

#### LIFE-SAVING AWARD

Mayor Davin and Police Chief Payne then came forward to present awards to those who helped with the August 11, 2008 lifesaving effort for a man who collapsed in the 100 block of Washington Street and went into cardiac arrest.

Those involved in the incident and honored with individual plaques from St. Margaret's Hospital were Sgt. Kaskie, Officer Crow, Oakview Avenue resident Mrs. Boles and VFD member, Mr. Halle. The Mayor and Chief Payne offered thanks to all involved.

#### COMMITTEE ACTION

#### M-1 Mr. Cook moved to approve the minutes of April 20, 2009. Second by Mr. Reynolds.

DISCUSSION: None.

Upon roll call vote, the following was recorded: Ms. McDonald, Mr. Shultz, Mr. Reynolds, Mr. Szefi, Mr. Cook voted yes. **Motion carried**.

Mayor Davin reported that the year-to-date figures for 2009 were lower than 2007 and 2008 for Parts I and II grand totals. She then commended Chief Payne for the statistics. Mayor Davin asked the Chief what "other crimes" constituted in the Part I crimes.

DISCUSSION: Mr. Reynolds gave kudos to Officer Lawrence for assisting in an armed robbery capture. Chief Payne stated that an arrest in Swissvale was made and Officer Livingston apprehended the actor.

#### PUBLIC SAFETY

Mr. Reynolds read the highlights of the report and stated that the Committee did meet and one of the issues was the use of patrol rifles.

DISCUSSION: Ms. McDonald said that the Public Safety Committee has a list of questions regarding policy consideration.

Mr. Reynolds talked about swift-reach emergency notifications to Edgewood residents.

Mr. Szefi said that the Committee did not meet and proceeded to read the highlights of the report.

Mr. Cook had nothing to add to the report presented in the packets. He stated that he and the Borough Manager met with Western Pennsylvania School for the Deaf on numerous issues which will be presented at a later date.

Regarding the tree survey, a report has been done and will be presented to the Borough's arborist, according to Mr. Cook. He also stated that Mr. Cecconi will meet with Duquesne Light about trimming of trees.

Mr. Reynolds said that there has been close communication regarding the Train Station in conjunction with Mr. Grubb.

DISCUSSION: Mr. Cecconi stated that he met with Mr. Avon regarding the windows and said that Mr. Avon is putting out bids in June or July with an anticipated starting date sometime in August.

Mr. Cecconi said that a public meeting will be held June 9, 2009 at 7:00 PM for public input into the finalized study of the Edgewood Avenue Revitalization Project. Mr. Cecconi said that he will place something on the website about this. He also said that Port Authority Transit will be doing a mini-presentation.

## EDGEWOOD PRIMARY SCHOOL

Ms. McDonald stated that the Committee did not meet, but reported that she met with Dr. Driscoll at the enrollment lottery and had an interesting and encouraging conversation. It was stated by Dr. Driscoll that the District felt that Edgewood stopped talks with them; it was decided that the dialogue would begin again with them.

Ms. McDonald also reported that the Rankin School will close and some of the students will be merged into the Edgewood Primary School classrooms.

DISCUSSION: Mayor Davin spoke with regard to the school buses on Maple Avenue and her concern for emergency vehicles getting through. She felt that the additional buses will pose a bigger problem if the school expands to K-6<sup>th</sup> grade.

Mr. Reynolds said that the Fire Department talked about discharging the children on Hawthorne Street.

Mr. Cook had concerns about the sixth and first graders being released at the same time and suggested a meeting on this topic sometime in June.

Ms. McDonald suggested a meeting after June 12, 2009 with Dr. Calinger, Chief Payne, the Edgewood Fire Department and the principal.

Mr. Cook suggested that the Ad Hoc Committee meet one-half hour before the meeting to ensure continuity of the group.

Ms. McDonald also report that Dr. Driscoll stated that money was not the issue with the governor's drive. As an aside, Ms. McDonald also noted that her son was the first student chosen in the lottery.

# PARCEL D COMMITTEE

Mr. Szefi noted that the Committee did not meet and was currently in a holding pattern.

# BOROUGH MANAGER REPORT

Mr. Cecconi said that Duquesne Light will be here for a meeting Tuesday. He also reported that he met with three (3) contractors on the Allenby sewer.

DISCUSSION: Mr. Cook mentioned that the meeting with Duquesne Light is not to dictate, but to partner with them and possibly have this program become a model for other municipalities.

Mayor Davin asked if the two (2) trees have been purchased for South Braddock Avenue and Mr. Cook said he is waiting for the Foundation to provide the check for the trees.

The Mayor indicated that last year's winner of the Limpert Award requested that a tree on South Braddock be replaced and the 2009 winner of the Award will also have a tree planted. The Mayor asked that bigger sized trees be planted, if possible.

Mr. Cecconi reported that he is looking at garbage can prices and is working with Regent Square Civic Association for donation of three (3) cans for the Edgewood side of the Braddock Avenue business district.

#### ALLEGHENY COUNTY, PENNSYLVANIA

#### **ORDINANCE NO. 1029**

AN ORDINANCE OF THE BOROUGH OF EDGEWOOD, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, CREATING HANDICAPPED PARKING AND PRESCRIBING PENALTIES FOR VIOLATION FOR SPACE AT THE FOLLOWING ADDRESS: 708 WALNUT STREET

NOW, THEREFORE, be it ordained and enacted by Council for the Borough of Edgewood,

and it is hereby ordained and enacted by the authority of same as follows:

<u>SECTION 1</u>. One handicapped parking space shall be created at the curb line of **WALNUT STREET** in front of **708 WALNUT STREET** in the Borough of Edgewood to be marked and used for a handicapped parking space; and

<u>SECTION 2</u>. The handicapped parking space shall be permitted upon issuance of a permit by the police of the Borough of Edgewood for a period of one year and upon the expiration of one year to be submitted and reevaluated by the Council of the Borough of Edgewood for approval for an additional year with the process to continue from year to year until the handicapped need is removed or the premises are sold; and

**SECTION 3**. In the event that there is no longer a need for a handicapped space or in the event that the property has been sold, the handicapped parking permit shall be removed and all signs indicating space shall be removed; and

<u>SECTION 4</u>. Any person who shall violate any provision of this ordinance by parking in said handicapped space without proper handicapped identification shall upon

conviction thereof be sentenced to pay a fine and costs in accordance with the Pennsylvania Motor Vehicle Code 75 Pa. CSA Section 3354; and <u>SECTION 5</u>. Any Ordinance, or any part of any Ordinance, in conflict herewith is hereby repealed to the extent of such conflict.

**SECTION 6**. It is the intention of Borough Council that the provisions of this Ordinance shall become part of the Codification of Ordinances of the Borough of Edgewood and that said Codification shall be amended and supplemented accordingly.

DISCUSSION: Mr. Cecconi asked if psychological testing is done at hiring and Solicitor representative Worner said he will check.

It was Mayor Davin's opinion that she would recommend this being done because these employees are dealing with fire.

Following more discussion, Messrs. Reynolds and Cook respectively withdrew their motion and second and the motion was re-read.
