BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING OF JUNE 15, 2015

President Schaefer called the meeting of the Borough of Edgewood to order at 7:34 pm in the Municipal Building.

ROLL CALL

Upon roll call, the following responded: Mr. Bright, Mr. Wainright, Mr. Wilson, Mr. Fuller and Ms. Schaefer. Dr. Petrolla arrived at 7:45 PM.

Mayor Cook and Solicitor Barry were also present.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

ITEMS FROM THE FLOOR

Mr. Miller said the Regent Square Civic Association would be hosting a ramp litter clean-up on Saturday June 20th from 9 am, and for anyone interested in volunteering to meet in the lower parking lot at the CLASS building.

AUTHORIZATION TO PAY BILLS

Mr. Wainright moved to authorize the payment of bills, for goods and services received by the Borough, having been reviewed and approved by the General Government Committee, from the General Fund, in the amount of \$394,850.24 and from the Sewer Fund in the amount of \$147,742.73 for a total of \$542,592.97. Second by Mr. Wilson.

GENERAL GOVERNMENT Mr. Wainright said the largest expense in the bill list was the payoff on the Borough's tax anticipation note. He also said the general government committee recommended putting \$189,015.07 from the Borough's PLGIT capital reserve fund into a CD with a 0.9% interest rate.

POLICE REPORT Mayor Cook said the monthly report shows a decrease in shoplifting, but pointed out that Giant Eagle now handles a majority of their shoplifting cases in-house.

PUBLIC SAFETY Mr. Fuller said the public safety committee did not meet.

COMMUNITY DEVELOPMENT Mr. Bright said the committee did not meet.

PUBLIC WORKS Mr. Wilson said the committee would schedule a meeting this month.

COMMUNITY SERVICE Dr. Petrolla said the committee would schedule a meeting this month to discuss litter, Community Day, and Dickson Park.

PERSONNEL Mr. Fuller said the committee did not meet.

PENSION Mr. Bright said the committee did not meet.

AD HOC COMMITTEES

3 RIVERS WET WEATHER DEMONSTRATION PROJECT/CONNECT Ms. Schaefer said there was a 3 Rivers Wet Weather Board meeting on Friday June 12th, and that they were still working on the transfer of trunk line sewers to ALCOSAN.

SOLICITOR'S REPORT Mr. Barry said he reviewed the two agreements on the agenda and found them satisfactory.

BOROUGH MANAGER'S REPORT Ms. Bastianini said Movies in the Park was rained out on June 6th, and on June 22nd Dolphin Tale 2 would be shown. She updated Council on the contents of the Borough's solid waste and recyclable bid specifications, and also reported on Tyree Johnson's Eagle Scout project.

NEW BUSINESS Ms. Schaefer called a committee of the whole meeting for June 29th at 7 pm. A public works committee meeting was scheduled for June 22nd at 6pm, and a community services committee meeting was scheduled for June 22nd at 6:30 pm.

M-9 Mr. Fuller moved to enter into the East Hills DUI Task Force Municipal Police Cooperative Agreement.

DISCUSSION: Ms. Bastianini explained that the Borough's Police Department joined the East Hills DUI Task Force last year, and that Edgewood Police Officers helped at DUI checkpoints in the participating municipalities, and that those municipalities would help when a check point was set up in Edgewood.
