BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING OF SEPTEMBER 19, 2016

Vice President Fuller called the meeting of the Borough of Edgewood to order at 7:32 pm in the Municipal Building.

ROLL CALL

Upon roll call, the following responded: Mr. Bright, Dr. Wallace, Mr. Wainright, Mr. Wilson, Dr. Petrolla and Mr. Fuller.

Mayor Cook and Solicitor Barry were also present.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

ITEMS FROM THE FLOOR

Matt Divelbiss - 327 Chestnut Avenue

Mr. Divelbiss spoke on behalf of the Edgewood Foundation. He recapped their Community Day activities, and said that the sleepover in the park was canceled due to inclement weather. He said that Oktoberfest would be on October 1st at Koenig Field, with tickets available on the Foundation's website and proceeds to benefit Edgewood parks. He also said that Light Up Edgewood would take place on December 2nd. He asked that any new ideas be brought to the Foundation prior to their board retreat in January.

Ben Love -112 Race Street

Mr. Love said that he noticed a water main break on West Hutchinson Avenue, and asked what the Borough's responsibility was during these events. Mr. Fuller said the Water Authority was responsible for closing the roadways, making any necessary repairs, and restoration of the roadway. He said the Borough ensured that the restoration met code.
