BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING OF FEBRUARY 20, 2018

Upon roll call, the following responded: Mr. Bright, Dr. Wallace, Mr. Wainright, Mr. O'Donnell, Mr. Fuller and Ms. Schaefer. Dr. Petrolla arrived at 7:35 pm.

Mayor Wilson and Solicitor Barry were also present.

AD HOC COMMITTEES

3 RIVERS WET WEATHER DEMONSTRATION PROJECT/CONNECT Ms. Bastianini discussed CONNECT's work with the Allegheny County Health Department to combat the opioid epidemic in the CONNECT communities. She also discussed the formation of a municipal advisory subcommittee for the ALCOSAN board.

SOLICITOR'S REPORT Mr. Barry discussed the Borough's bed and breakfast ordinance, and how it does not apply to short term rentals. Ms. Schaefer referred the discussion to the general government committee for further research.

BOROUGH MANAGER'S REPORT Ms. Bastianini updated Council on her conversations with Giant Eagle about installing a crosswalk at S. Braddock Avenue and Towne Centre Drive. She congratulated Council on Edgewood once again receiving a Banner Community designation from the Allegheny League of Municipalities. She also updated Council on ongoing code enforcement priorities for the Borough.

NEW BUSINESS Dr. Wallace called a pension committee meeting for March 6th at 6:30 pm in Council Chambers.
