BOROUGH OF EDGEWOOD MINUTES OF THE PUBLIC HEARING OF APRIL 2, 2018

CALL TO ORDER

President Schaefer called the meeting of the Borough of Edgewood to order at 6:34 pm in the Municipal Building.

ROLL CALL

Upon roll call, the following responded: Mr. Bright, Dr. Wallace, Mr. Wainright, Mr. O'Donnell, Mr. Fuller and Ms. Schaefer.

Solicitor Barry and Junior Councilperson Lehrian were also present.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

ITEMS FROM THE FLOOR

President Schaefer asked for items from the floor to receive public comment on the application by Scene 75
Pittsburgh Entertainment Center, LLC to transfer liquor license #R-20022 to restaurant located at 1775 S. Braddock Ave.

Mark Kozar - Flaherty & O'Hara

Mr. Kozar spoke on behalf of his client, Scene 75 Pittsburgh Entertainment Center, LLC. Mr. Kozar spoke to the nature of the Scene 75 business, which is an indoor family entertainment center with arcade games, bowling, bounce room, go karts and mini golf. Scene 75 will also have a restaurant and food offerings, and is requesting a liquor license transfer in order to serve alcohol to compliment the food service. Mr. Kozar said at Scene 75's three Ohio locations, alcohol sales account for 6% of total sales. Mr. Kozar said Scene 75 only allows those over the age of 21 to handle or serve alcohol, even though law permits anyone over 18 to serve alcohol. He discussed on site security, carding policies and hours of operation. Mr. Kozar said Scene 75 was investing \$8-10 million into this facility, and that this investment would be followed by responsible liquor management.

A discussion followed about security at the location.

Mr. Fuller moved and Dr. Wallace seconded to adjourn the meeting at 6:55 pm.
