# BOROUGH OF EDGEWOOD MINUTES OF THE COUNCIL MEETING HELD MARCH 18, 2019

#### **ROLL CALL**

SHADE TREE COMMITTEE REPORT: Merrill Marcovsky presented the replanting plan for Memorial Park. Ms. Schaefer asked the manager to verify Nine Mile Run's consulting fee and to find out whether the proposed Elm trees would be disease resistant. The entire plan will come in at or under the budgeted amount of \$3000. Volunteers will be sought for a May 4, 2019 planting.
